The Chairman, Balurghat Municipality, invites e-Quotations (electronic quotation process), to obtain rate for "Supply, installation & shifting of Air-conditioner machines at Balurghat municipal office building.

Details of quotation with necessary requirement towards submission/download of Quotation Papers will be available from website: http://etender.wb.nic.in or http://wbtenders.gov.in directly with the help of Digital Signature Certificate (DSC).

- Applicants willing to take part in the process of e-Quotationing will have to be enrolled & registered with the Government e-Procurement system; through logging on to http://wbtenders.gov.in using the option - Click here to Enroll. Possession of a valid Class II Digital Signature Certificate (DSC) in the form of smart card/e-token in the Company's name is a prerequisite for registration and participating in the Quotation submission activities through this web site. Digital Signature Certificate can be obtained from the authorized certifying agencies, details of which are available in the website http://wbtenders.gov.in
- Intending Quotationers can search and download NIe-Q and other Quotation documents electronically by logging on to the website http://wbtenders.gov.in, using his Digital Signature Certificate (DSC). This is the mode of collection of Quotation documents electronically.
- 3.
