Eligibility of Contractor : Govt. licensed electrical contractor having supervisory competency certificate Part 1,2,4&11 and having credential for outdoor electrification works (other than maintenance works) in a single tender of value at least 40% of the estimated amount put to tender executed under Govt. department, municipality and WBSEDCL within last 5(five) financial years.

13. Time of completion of work : 15 days.
14. Terms and Conditions : 3 (three) years maintenance cost will borne by the agency.

Intending tenderers are requested to quote their rates after having been verified the rates with concerned schedule of rates and site condition well in advance. All documents will have to be submitted with a self-attestation with a certificate as "produced by me" on each document. Submission of "No Objection Certificate" from A.R.C.S. in case of Engineer's Co-operative is must. Contractors failing to submit tender documents in the tender box will not be allowed to participate in the next two consecutive tenders.
